Canaan Township Board of Trustees Regular Meeting December 10, 2024 Minutes

Vice-Chairman Matthew Carwell called the meeting to order at 7:00 PM. Roll call showed trustees Matthew Carwell and Tyler Levering present as well as fiscal officer Jill Retterer. Trustee John Bayles was unable to attend due to a family emergency.

The fiscal officer presented the minutes from the November 12, 2024, regular meeting. Mr. Carwell made the motion to approve the minutes. Mr. Levering seconded the motion. Motion passed.

The fiscal officer reported receipts and balances to date in all funds. The bank reconciliation report was also presented. Automatic drafts were examined. The Park National Bank and STAR Ohio Statements were also distributed. Credit card purchases for November and early December were reviewed and the attestation statement signed by Mr. Carwell. Mr. Levering made the motion to approve the reports and pay the bills. Mr. Carwell seconded the motion. Motion passed.

Mr. Levering made a motion to pay the trustees compensation for 2025 as follows: 80% out of the gas tax fund and 20% out of the general fund. The fiscal officer will be paid 100% out of the general fund. Mr. Carwell seconded the motion. Motion passed.

The trustees checked all the roads on Tuesday, December 3rd. It was reported that several townships and the county have noticed an increase in theft of road signs. Several signs have been stolen from Troy, Congress, and Washington townships. The trustees noted the only sign missing in Canaan Township is the Twp. Rd. 73 sign at the intersection of Co. Rd. 67. The trustees will replace that sign soon. The Road Sign Inventory and Management form was completed and is on file.

Small's Asphalt and Paving completed, in early November, the OPWC Phase 4 paving and widening of Twp. Rd. 60 between Twp. Rd. 67 and Co. Rd. 61. The total cost of the project was \$188,513.21. The engineer's estimate was figured at \$149,514 and was the estimate used to submit the application. That estimate had some errors in quantities of material that affected the overall cost of the project. The OPWC grant covered up to 74% of the cost from the engineer's estimate which was \$110,640. The township was responsible for the balance of the project which was \$77,872.21. Since the township began applying for OPWC grants in 2012 they have received over \$1,030,000 in grant money for road improvements. The township has paid approximately \$404,000 out of township funds to cover their portion of the OPWC projects.

Theres was no First Consolidated update.

There was no Regional Planning update.

Receipts were collected for the OTARMA MORE Grant application. The trustees purchased new smoke/CO2 detectors for the township hall and new tri-buster sign stands and post reflectors from Newman Signs. The registration fee for the OTA Conference will also be turned in as part of the allowable uses for the grant money. The grant this year increased from \$500 to \$1,000. The township has \$908.28 in allowance expenses to turn in.

The trustees reviewed the four mowing quotes they received for the 2025 mowing season which is April 1, 2025, to October 31, 2025. The quotes were as follows: Lewis Lawn Care and Landscaping for \$15,450; Rob Schelb for \$14,725 with a 3% discount if paid in full up front; Shumaker Lawn Care for \$12,740; and Zach Faust for \$10,000. Mr. Faust is familiar with mowing for the township as he did a lot of the mowing the last few seasons under Gene Ebert with Ebert's Lawn and Landscaping. The trustees were pleased with the quality of Mr. Faust's services. Mr. Levering made a motion to accept the bid from Zach Faust to provide mowing and trimming of the Canaan Township Cemeteries and the Township building for April through October. Mr. Carwell seconded the motion. Motion passed.

The meeting day and time for regular meetings will remain the same for 2025. Regular meetings will be held on the second Tuesday of each month at 7:00 p.m. The Organizational meeting for 2025 will be held on Tuesday, January 14, 2025, during the regular meeting time.

The IRS mileage rate for 2025 is estimated to be between 68 and 70 cents per mile driven for business use. The final amount has not been released as of this meeting. Mr. Carwell made a motion to provide mileage reimbursement at the IRS rate for 2025. Mr. Levering seconded the motion. Motion passed.

Updated driver's licenses and insurance policies for the trustees will be turned in as new licenses are issued and as insurance policies are renewed for each trustee.

A special end of the year meeting will be held Friday, December 27, 2024, at 6:00 p.m. at the township hall. The purpose of the meeting is to complete and finalize any year end business before the books are closed for 2024.

There being no further business to come before the board, Mr. Levering made the motion to adjourn. Mr. Carwell seconded the motion. Motion passed. The meeting adjourned at 8:30 PM.
